No: GP-28-PNDT-102006-GOI-190-GH:- In exercise of the powers conferred by sub - section (2) of section 17 of the Pre-conception and Pre-natal Diagnostic Techniques (Prohibition of Sex Selection) Act, 1994 (57 of 1994) and in super session of the Government Notification, Health and Family Welfare Department, No: GP-30-MPT-1096-553-GH, dated the 9th November, 2001, the Government of Gujarat hereby appoints the officers specified in column 2 of the schedule annexed hereto be the Appropriate Authorities for the areas specified in Column 3, thereof respectively for the purposes of the said Act having regard to the intensity of the problem of the Pre-Conception and Pre-natal sex determination leading to female feticide.
